## Socioeconomic Implications of Chinas Belt and Road Initiative (BRI) into Pakistan

China has embarked on a massive infrastructure development projects across and through its western neighbors, including the China-Pakistan Economic Corridor which grants China a quick access to the Arabian Sea and alleviate its strategic security concerns regarding its vulnerability to the Malacca dilemma, and improves Pakistans economic aspects of job creation, infrastructure development, and technology transfer. The differences between the economic prospects and the societal values between the two nations are bound to raise tensions and conflicts, with some already manifested in the early implementation stages of the project. This paper highlights the implications and pitfalls to avoid for both countries.





### Water Conservation Measures In The Hotel Sector In South Africa

**Keywords:** Hotels, Water Conservation, Resource Management

Due to its function, operating characteristics and services provided, the hotel sector consumes large amounts of water and non-durable products. Water use within the hotel is further influenced by operational elements such as catering outlets, laundries, swimming pools and spas, recreational facilities, customers awareness of resource consumption and services offered. Over-exploitation of water resources can be problematic in areas that have scarce water resources. Therefore, the primary objective for many hotels is to reduce the consumption and wastage of water, and the aim of this paper is to examine the measures used to conserve water in the hotel sector in South Africa. A total of 142 star-graded accommodation establishments were identified for the study. A census of all star-graded hotels were included the study and a total of 60 completed questionnaires was completed and used in the study. The data indicated that water consumption tends to be highest in rooms, laundry facilities and kitchen facilities. The linen and towel re-use program was cited as the most common water conservation action practiced by most hotels and lodges in the study. Low flow showerheads have been installed in more than half of the hotels and lodges in the study. Low flow taps and dual flush toilets were non-existent in all 1 star hotels and lodges. The majority of hotels and lodges educated staff on how to save water. One star and 2 star hotels and lodges showed the least commitment to water conservation measures. Similarly, independent hotels and lodges revealed a lesser involvement in water conservation measures compared to chain hotels and lodges. As a water-stressed country, South Africa requires more responsible initiatives aimed at conserving water.

# Legal Protection of Creditors' Guarantee Holders in the event of a Bankruptcy to the Debtor Based on Law No. 37 of 2004 Concerning Bankruptcy and Suspension of Debt Payment Obligations

In providing credit or debt, sometimes creditors want to get a sense of security. The definition of credit itself is trust where this trust gives a sense of security to the creditor. The sense of security that comes from the belief that the debtor can pay his debt whatever happens. In the business world, businesses run by debtors are often unsuccessful. Failure to conduct this business often goes bankrupt. Bankruptcy according to Indonesian law occurs when a debtor has two or more creditors, in which one of the debts of the creditor is due or has been billed. This makes bankruptcy often easy to happen. In the event of a bankruptcy a creditor in good faith needs to be protected. Creditors guarantee holders get earlier protection than other creditors. In the bankruptcy law in Indonesia it is regulated that the creditor of the guarantee holder can directly execute and auction as if bankruptcy did not occur. This can protect the creditor in good faith so that the creditor can obtain legal protection. The guarantee it receives is a belief that if a debtor goes bankrupt, then the creditor receives protection, that is, the creditor gets repayment first.

## Money Guarantee As A Terms For Granting Of Land Management Licences As An Efforts To Strengthen Company Strict Liability And As A Prevention Of Forest Fire

Natural resource management is a economic strategic sector owned by Indonesia which includes the management of land, water, air, and all kinds of natural wealth contained within the jurisdiction of the Indonesia. The obligation of the Indonesia as a country is to preserve a harmonious and balanced environment is closely related to the practice of good evironmental governance. In Indonesia it self, the problem is that the corporate governance that often occurs is air pollution due to the forest and land fires. Even so there are some problems in law enforcement when asking fot the businessman responsibily, especially in the case if of corporation as a bussiness entity. This research will try to focus on how the consept of a Money Guarantee between the Government as an authorized agency with the business actors berfore the start of a business/ activity can strengthen the concept of strict liability. This research uses normative juridical method. The Secondary data was obtained from a legislative literature review and govement regulation that regulate about the granting of peatland management permits and company strict liability. The conclusion of the this reasearch topic discussion is that concept of strict liability as regulated in Article 88 of Law Number 23 of 1997 about Environmental Managemen, and then been renewed in Law number 32 of 1999 about The Protection and Management of Environment is a Lex Specialis of tort in Article 1365 of Civil Code where the element or faulth does not need to be proven by the plaintiff as a basis for the damage. However, an effort to strengtehen and deterrent is needed by adding a deposit instrument or money guarantee before the company starts a business in environmental management sector. Thus deposit can be implemented and regulated through a Indonesia Government Regulation or through Minister of Enviroment Regulation in which it regulates that the company is responsible for the area of its teritory activity, which is led to the automatically responsible to maintaining and to protect the areas wheres the business license is valid. If the company cannot maintain and protect the fotest fires then the security deposit can be used to overcome and to restore the impact of the fire forest.

## Arrangement of Private Pawn in Business Development in Indonesia in the Perspective of Legal Protection for Private Pawn Recipients and Legal Responsibility for Private Pawnbrokers

In an effort to meet the needs of daily life often requires cash, but the problem when cash is needed actually does not have cash in hand, because they are still waiting for accounts receivable that have not matured, or the need for cash suddenly due to urgent needs. Pawn is an alternative financial institution that offers financial assistance to the public. Pawn in Indonesia is regulated in the Financial Services Authority Regulation POJK Number 31 / POJK.05 / 2016 Regarding Pawnshop Business. A pawnshop company in Indonesia consists of a Government Pawn Company in the form of a Public Corporation Pawn (PT Pegadaian Persero) and a Private Pawn Company. Private pawn companies provide many facilities in terms of procedures, guarantees and disbursement of funds. People began to use a lot of services from Pawn Private. In practice, many private pawns do not have licenses as stipulated by the Financial Services Authority (OJK). The problem arises whether the community as consumers get good protection if they use private pawn shops, then to what extent is the responsibility of pawnshop entrepreneurs if the private pawnshop in carrying out its operations has not yet obtained the license from the Financial Services Authority (OJK). Research Methods conducted in this study were conducted using the Normative Juridical Method. Data collection is carried out with a focus on secondary data sourced from library studies. The approach method used is the statutory approach method, the conceptual approach method. Data analysis was performed using qualitative analysis. Private pawnshop businesses must be regulated so that the public as consumers get the legal protection they should. There is a need for a private mortgage license, periodic reporting, the qualification of the manager of a private pawnshop business, and the provisions regarding the proper and responsible storage of collateral. The important thing to strive for is the existence of regulations on private pawnshop at the level of legislation in order to better guarantee the creation of legal protection and ensure that pawnshop entrepreneurs have the responsibility in conducting private pawnshop businesses.
